Dear Friends of Pathway Caring for Children,

This past year has been filled with many new and exciting opportunities for our children, families and our staff. Here are a few highlights:

- 3 new school districts are being served by Pathway mental health therapists and case managers, amounting to 7 school districts where we address the social, emotional, and behavioral issues students face every day. These include Beacon Academy, Brown Local, Fairless Local, Heritage Christian, Minerva Local, Osnaburg Local, and West Branch Local Schools.
- 15 of our teens graduated from high school; several are attending local colleges along with working jobs to support themselves, and others went straight into the workforce to pursue their career passions.
- 16 new foster families have been licensed and therapeutically trained to welcome children from hard places into their homes.
- 20 Pathway foster children are in adoptive homes. Several families have finalized adoptions and Pathway staff continue to guide others through the legal process. We celebrate with each family who has embarked on this lifelong journey and Pathway's wraparound post-adoption support is there every step of the way.
- 27 young adults are enrolled in our Bridges Program. Bridges is a new program aiding individuals ages 18-21 who have aged out of Ohio's foster care system. Pathway case managers provide more support and resources to Bridges clients which include housing, financial assistance, employment and life skills, and furthering their educational opportunities.
- 45 teens attended our TRUST Adventure Therapy Camp at Camp Koinonia. (Teens Realizing and Understanding Selves Together) This year's TRUST Camp was the camp like no other. These campers came with open hearts, willing attitudes, and a desire to be part of something amazing! An opportunity staff and teens look forward to all year long.
- 90 volunteers provided 1,311.50 hours of involvement. Each person bringing a special skill set that enhance our programming and day-to-day operations.
- 800+ children, teens, and families were served by Pathway as we join them in their path to find healing and purpose.

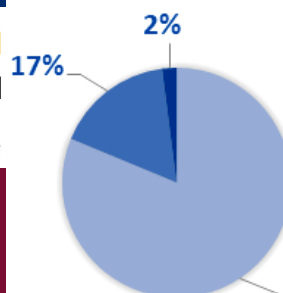

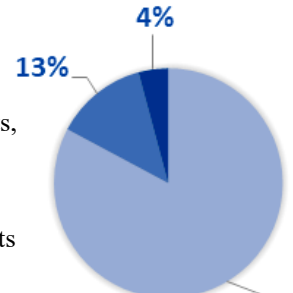
